MEMORANDUM FOR MR. PETER FLANIGAN

SUBJECT: Matters discussed with the President

I am attaching a "Chinese" copy of my notes from the meeting this morning with the President. (The numbers below are to identify with the notes.)

II. Areas Identified by the Council for Study

The President said to give "Social Programs" the "highest" priority.

In the areas which we had listed as "second level," the President made these comments:

Natural Resources: "High"

Consumer Affairs: "High"

Regulatory Agencies "High"

Urban Mass Transportation: "Yes"

Indians: "Yes"

III. Agenda for July 17-19 Council Meeting

The President indicated he would like to meet with the Council for a half hour on Thursday, July 17th.

IV. What might the President do to help the Council carry out its program and emphasize the importance of its undertaking.

A. The President said such a memorandum (Tab IV) should go to the heads of all executive departments and agencies. The President did not read the memorandum, however, and although I have consulted the Bureau of the Budget concerning its form and substance, I would feel more comfortable if it were reviewed by someone on the White House staff.

B. The President said that a Council Member, or appropriate representative of the Council, should attend the Urban Affairs Council meetings and Environmental Quality Council meetings.

The President discussed "Economic Policy" meetings and said that I should be invited to attend.

It was suggested that I should attend a Cabinet meeting (in California probably) and outline the program of the Council. (Perhaps this should be Roy Ash, or both of us.)

The President thought that I should attend a Leadership meeting and outline the work of the Council.

My impression was that the President agreed our Council should sit—in on all high level meetings where organizational problems were on the agenda. The meeting this morning in the Cabinet room certainly indicated the validity of this suggestion as it is of the utmost importance the Council and its staff be kept current with respect to discussions having a bearing on organizational changes.

V. Coordination

B. The President confirmed that you are the person in the White House for us to keep advised concerning our activities.

VI. Council meeting in California in August

The President confirmed that the Council should have a "full meeting" with him in California in August. I would like to get the date for such a meeting as early as possible so that I can discuss it with the Members of the Council and get it on their calendar.
